

## **Roads (Works, Use and Compensation) Ordinance (Chapter 370)**

### **Scheme annexed to Plan No. SDO-Z0507 under section 5 describing**

#### **PWP Category D Item**

#### **Walkway Cover at Sham Mong Road / Hoi Lai Street in Sham Shui Po**

#### General Description of the Works

Under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (“the Ordinance”), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. SDO-Z0507 (“the Plan”) annexed hereto and described hereunder. The proposed road works are required to provide cover on the walkway at Sham Mong Road / Hoi Lai Street in Sham Shui Po for public use.

2. The general nature of the proposed works is as follows: –
- (i) construction of a walkway cover;
  - (ii) permanent closure and conversion of sections of the existing carriageway into refuge islands;
  - (iii) permanent closure and conversion of sections of the existing footpaths into columns;
  - (iv) permanent closure and conversion of sections of the existing refuge islands into carriageways;
  - (v) temporary closure and reconstruction of sections of the existing carriageway, footpaths and refuge island; and
  - (vi) ancillary works including drainage, road marking, public lighting, landscaping, utility works, and installation of street furniture.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 17 of the Ordinance may be exercised to close permanently sections of the existing carriageway, footpaths and refuge islands, and temporarily sections of the existing carriageway, footpaths and refuge island within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageway, footpaths and refuge islands are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, drainage pipes, sewerage pipes, gas pipes and any other service apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
